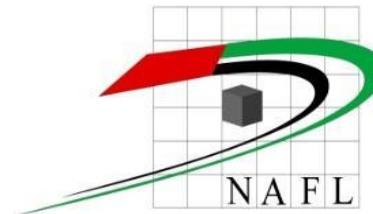

Customs Clearance Procedure for Food Items

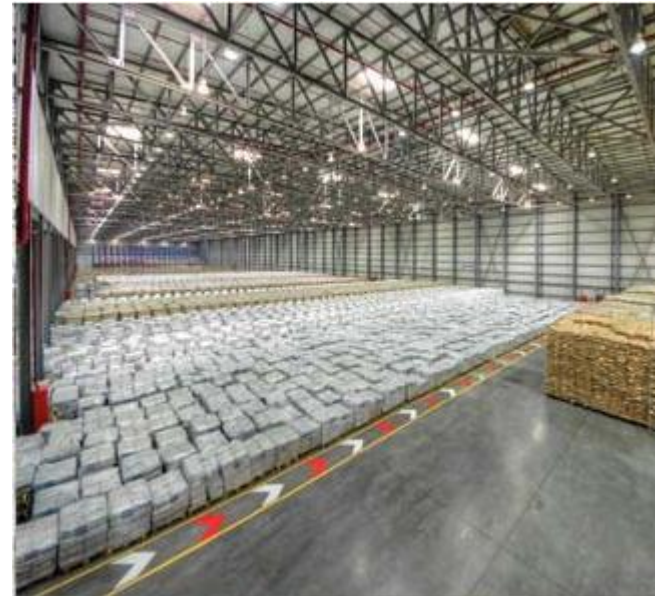
- ❖ FLS team understands processes and procedures required for customs clearance of FMCG in UAE.
- ❖ Delivery Order (D.O.) – documents required are Original BL or Surrendered BL and Authorization letter from consignee.
- ❖ Food Import Re-Export System - FIRS report can be processed by consignee/ FLS.
- ❖ Free Zone Transit-in bill (BoE) – documents required in Original are Invoice, Packing List, Certificate of Origin (CoO) and FIRS.
- ❖ Inspection
 - ❖ Mandatory inspection by Dubai Municipality for which the trucker must carry.
 - ❖ Originals of BoE, Health certificate, Free Sale certificate, Phytosanitary certificate (for plant related foods).
 - ❖ Copies of Invoice, Packing List, CoO and FIRS.
 - ❖ Dubai customs inspection – will be on case to case and only if appearing on the BoE.
- ❖ Delivery to Warehouse for storage – subject to inspection clearance, the goods can be moved to the warehouse for storage.
